

The Rules of Conduct for Spectators

Access to PFC CSKA Stadium assumes that spectators accept and voluntarily observe these Rules in effect during the entire period of spectators' stay at the stadium.

At official competitions (including arrangements connected with concert, entertainment, business or public events) Spectators shall have the right to:

- respect and protection of the person's dignity;
- receiving of the required and reliable information about the procedure for stay at the Stadium and exit there from, about restrictions and prohibitions connected with visiting the Stadium;
- delivery of the required health care subject to applicable RF legal requirements;
- entry into the Stadium for viewing events subject to presentation of an entrance ticket or an equivalent document with an exception of cases where a spectator is subject to an administrative ban preventing him from visiting a Stadium;
- presence at the Stadium during the entire period of the event delivery;
- making use of all services provided at the Stadium;
- occupy individual spectator's seat as indicated on the entrance ticket or an equivalent document
- use access routes to the individual spectator's seat with soft drinks in plastic or paper cups and meals purchased in special points of sales located at the Stadium;
- for carrying and use of:
 - personal belongings not forbidden for carrying under these Rules;
 - means of fan support complying with requirements of these Rules;
- for supporting participants of the events in a standing position in the absence of objections on the part of other spectators;
- driving of personal vehicles to the Stadium or to the parking space subject to a vehicle pass issued by an organizer of the official sports event or an owner (user) of the sports facility;
- use toilet rooms (cabins) located at the Stadium free of charge;
- safety of personal belongings left in the cloakroom located at the Stadium;
- assistance of on the part of persons involved in the arrangement of the event including the information to be obtained from the specified persons about provided services, spectators' seating, the Stadium entrances and exits as well as assistance in case of evacuation.

Spectators at PFC CSKA Stadium shall be obliged to:

- present an entrance ticket or an equivalent document at entrance to the Stadium, as well as a personal identification document in cases prescribed by the RF Government Decision, occupy individual spectator's seat as indicated on the entrance ticket or an equivalent document (if an individual spectator's seat is not indicated on the entrance ticket or an equivalent document – general admission);
- when driving a personal vehicle to the Stadium adjacent territory present a vehicle pass issued by an organizer of the event or by the Stadium administration;
- while entering or driving to the Stadium and (or) the territory adjacent thereto pass through personal search and make available for inspection personal belongings;
- leave in the cloakroom any unwieldy items except for cases when brining of unwieldy items is agreed upon with the event organizers;
- during the stay at the Stadium observe the public order and requirements prescribed by these Rules;
- show respect to other spectators, event organizers and participants, the Stadium administration and persons providing for protection of public order and public security;
- immediately report the cases of detection of suspicious items, violation of public order, smoke formation or fire development, medical emergency to controllers-stewards or other persons providing for protection of public order and public security while conducting official sports competitions;
- avoid causing property damage to other spectators, event organizers and participants, the Stadium administration and persons providing for protection of public order and public security while conducting official sports competitions; take goods care of the Stadium property and commit no nuisance;
- comply with legitimate demands of representatives of the event organizers, the Stadium administration, controllers-stewards and other persons providing for protection of public order and public security at the Stadium;
- upon receipt of information about the evacuation from the Stadium act in accordance with the instructions (directions) of persons providing for protection of public order and public security at the Stadium in accordance with the Fire Safety Rules and approved evacuation plan;
- avoid littering at the Stadium and on the adjacent territory.

It shall be prohibited for spectators at PFC CSKA Stadium to:

- stay at the Stadium being under intoxication offending the human dignity and public morality;
 - smoke at the Stadium;
 - engage in actions creating a threat to personal security, life, health as well as to security, life, health of other persons being at the Stadium or on its adjacent territory;
 - throw any things in the direction of other spectators, event participants and other persons being at the Stadium or on its adjacent territory;
 - offend other persons (using inter alia, banners, posters, placards, means of visual propaganda) and do other things discrediting honor, dignity and business reputation or aimed at arousing feelings of hatred or hostility as well as humiliation of human dignity or dignity of group of individuals on the basis of gender, race, nationality, language, origin, religious beliefs;
 - disguise their faces using inter alia, masks, except for cases specially established by the event organizers, as well as means of camouflage and other items specially designated to hinder establishment of identity;
 - abuse public morality and rules of behavior by way of indecent exposal of the person during the stay at the Stadium;
 - penetrate to the Stadium, territory adjacent thereto and the areas not indicated in the entrance ticket or equivalent document (engineering and utility services rooms, VIP areas, places intended for representatives of mass media) access to which limited by the event organizers and Stadium administration;
 - stay during the delivery of the event at staircases for a long time, aimlessly move around the Stadium, as well as disturb movement in the areas intended for evacuation, including inter alia passageways, exits and entrances (primary and emergency ones);
 - damage the property located at the Stadium and on the adjacent territory as well as place near them foreign items without respective permission of the event organizers and the spectators administration;
 - enter the Stadium with animals and birds except for muzzled guide dogs;
 - conduct public events not provided for by the regulations (rules) for conducting events;
 - bring to the Stadium and use:
 - weapons and ammunition of any type, stabbing and cut and thrust articles, other items, which could be adapted for use as a weapon, explosive, toxic, poisonous and strongly smelling substances, radioactive materials;
 - fire-hazardous and pyrotechnical products, pistol lights, flares, fireworks, pepper guns and items (chemical materials), which might be used for making of pyrotechnical articles or smokes;
 - other substances, items, articles including inter alia, home made ones, the use thereof may result in smoke spread, inflammation;
 - devices and other articles including inter alia, home made ones, which are not pyrotechnics to be applied for scattering;
 - dispersion of various materials and substances (pneumatic clapboards);
 - dyes and paints;
 - sound-emitting devices (including vuvuzelas) except for horns and pipes;
 - alcoholic beverages of any kind, drugs and toxic substances or stimulants;
 - food or soft drinks except for food and soft drinks for children under 10 years of age accompanied by an adult;
 - any propaganda materials of an extremist nature or containing Nazi symbols or attributes, or symbols or attributes of any extremist organization;
 - technical devices (laser devices, lamps), radio stations, sound reinforcement means (except for means of support specified in appendix to these Rules);
 - any unwieldy items disturbing other spectators except for cases when brining of such items is agreed upon with the event organizers;
 - carry out illegal trade (including selling of entrance tickets or equivalent documents), distribute of political, religious and racist nature (including posters, leaflets, booklets).
- In case of identification of an individual (including through video surveillance system) in respect of which it has taken legal effect a court ruling on administrative ban to attend places of official sports, concert, entertainment, business and other public events the competition/event organizer and (or) controllers-stewards shall have the right to deny access to the said person or expel such person from the place where the competition/event is held canceling its entrance ticket or equivalent document without compensation of its cost.



Means of fan support, which may be brought into PFC CSKA Stadium without prior coordination with event organizers, shall meet the following requirements:

- not contain inscriptions of political, extremist, provocative or advertising nature, virulent abuse, obscenities and indecent images;
- not contain Nazi symbols or attributes, or symbols or attributes of extremist organizations as well as symbols or attributes, which are confusingly similar to them;
- not intend to offend honor and human dignity of participants, spectators and event organizers;
- in respect of banners and flags – not exceed dimensions of 2 x 1.5 meters including those on hollow plastic poles that do not exceed 1.5 meter in length and 2.5 cm in diameter;
- not be an object the usage and (or) storage thereof is not permitted by the Russian Federation laws;
- provided with translation into Russian of words and (or) expressions, contained in the means of support in national languages of the Republics of the Russian Federation or in foreign languages certified under a notarial procedure or by the event organizers to be presented by the spectator to authorized person at entrance to the Stadium;
- means of support, which are not under mandatory prior coordination with an organizers of the official sports competition shall be put at places where they will not prevent other from viewing of the official sports competition.

Carrying of fan support means specified in these Rules, which do not comply with requirements set out to this effect shall be permitted subject to prior coordination by community of spectators with the organizer of the official sports competition or a person duly authorize him as well as with persons providing for protection of public order and public security while conducting official sports competitions.

Persons failing to meet requirements set out by these Rules or refusing to comply with such requirements shall be denied access to the Stadium or expelled from the Stadium or hold liable in accordance with the Russian Federation laws.

Compliance control over requirements set out by these Rules shall be imposed on event organizers, Stadium administration as well as on other persons involved in activities providing for protection of public order at the Stadium. Event organizers and (or) Stadium administration shall have the right to specify additional requirements to behavior of spectators at PFC CSKA Stadium.

"The territory of the Stadium" - it is a building of the Stadium, adjoining premises and areas being its part and/or used while conducting respective events as well as other facilities located at the plot of land at the address: 3-rd Peschanya Street, 2, Moscow
